



"Farewell Tour" Kicks Off at Reston Affordable Senior Housing Property as 300+ Seniors Prepare to Leave 1970s Building that Has Been an Integral Part of Reston's Founding Vision

Residents of Lake Anne Fellowship House, Reston's first affordable housing community for seniors, start preparations to move to new, modernized property that will provide enhanced amenities while still assuring that rent is never more than 30 percent of a resident's income, which averages \$10,000/year.

Feb. 2, 2022 – Reston, Va. – This summer, the 313 seniors who call Lake Anne Fellowship House (LAFH) their home will move from its 50+ year old building to a <u>brand-new state-of-the-art residence</u> across the street. This month, Fellowship Square officially kicked off "farewell" programming in preparation for this upcoming move to recognize and say goodbye to the aging building that has been an integral part of the Reston community since its construction in 1970 as one of the **first high rises** and the **first affordable senior housing property** in Reston. The 240-unit building will be demolished, then redeveloped, once residents are relocated to the new property being constructed in collaboration with <u>Enterprise Community Development</u>.

"Fellowship Square is taking the next several months to communally and collectively remember, reflect, share stories, and say good-bye to this community touchpoint that has served as a home for thousands of seniors over the past 50+ years. This residence has embodied the founding vision that Reston be a community for all income levels, races and religions," said Christy Zeitz, CEO of Fellowship Square. "We will be celebrating this building's and this community's contribution to housing diversity and affordable housing solutions in Reston, and the impact it's had on so many seniors with limited resources. At the same time, we're looking forward to our next chapter: the summertime move to a new modernized building that is the result of <u>collaborative partnerships</u> to help some of Virginia's most underserved seniors have a secure home where they can thrive."

An Essential Component of Reston's Founding Vision

Affordable housing communities like Fellowship Square have been an essential component bringing to life the <u>vision</u> of Reston founder and developer <u>Robert E. Simon</u>, whose goal was creating an open and welcoming community where everyone, regardless of income, race or religion, could live, work, play and remain throughout their lifetime. Over the past 50+ years, Lake Anne Fellowship House has provided housing to more than 1,300 low-income seniors, enabling vulnerable low-income residents to age in place in Reston, where explosive growth and expansion have driven prices up. While Reston is now one of the most expensive zip codes in the state, the senior residents at LAFH – many of whom live on Social Security or Supplemental Security Income alone, with an average annual income of approximately \$10,000/year – are able to remain in their local area and enjoy the dynamic Reston community.

"One Last Time" Farewell Programming and Community Open House

<u>"Farewell Tour"</u> programming will include monthly events for residents focused on celebrating the diversity of the Lake Anne community, such as New Year Celebrations Around the World, Culture through Crafts, a Flowers of the World spring garden event, move preparation workshops and more. An open house for family members, neighbors, neighboring organizations, local businesses, and the greater Reston community will be held in May to enable community members to visit the building "one last time," celebrate its role in the Reston vision, and to preview the changing and modernizing of the neighborhood with the new Lake Anne House facility being built across the street.

"With the new Lake Anne House nearing completion, the time is right for us to honor the old Lake Anne Fellowship House which has served as home to more than 1,300 Restonians over the past five decades. While the new Lake Anne House will also be adjacent to the cultural and historical center of our Reston community and will have much-needed upgrades – and I know its residents are really looking forward to that – it will be bittersweet to lose this longtime feature of our Reston landscape." -Walter Alcorn, Fairfax County Board of Supervisors, Hunter Mill District
