In 2023, Fellowship Square completed the award-winning redevelopment of its Lake Anne property, in partnership with Enterprise Community Development, preserving all 240 units and creating a modern, energy-efficient, and amenity-rich space that residents are proud to call home. Net proceeds from the sale of excess land near Lake Anne, and additional fundraising efforts, allow Fellowship Square to expand its affordable senior housing portfolio and services to seniors. Each Fellowship House offers a robust monthly calendar of programs and activities; and includes an onsite social worker to help residents navigate Medicare, Medicaid, and other federal and state benefits, and**
